It is hereby informed to all the students of 3 Year LL.B./LL.B. (Hons.), 5 Year B.A.LL.B. (Hons.) and their Parents Guardians too that the J.B. Law College authority has planned to re-open the college Post Lock Down due to COVID-19 pandemic following the SOP of Assam State Government as well as UGC guidelines with the following conditions:-

1. The classes of 5 Year B.A.LL.B. (Hons.) 1st, 3rd, 5th, 7th, 9th and 3 Year LL.B./LL.B. (Hons.) 3rd/5th Semester will start from 18th November, 2020.
2. The classes will be conducted in phases for all courses keeping in view the requirements of physical distancing.
3. In order to reduce the class size, up to 50% students will be allowed on a rotation basis to attend the classes.
Therefore, each semester shall be divided into required number of groups Roll No. wise.
4. Staggered time table has been prepared in the following manner-

9th Semester-> Monday – Wednesday – Friday – Saturday


AFTERNOON SESSION
